## **1. Invitation**

An invitation is extended to old style Gaff rigged boats, replicas, originals, trailerable or not. Entry forms along with full payment must be submitted by 1700 hrs on wednesday 1st of June 2022.

## **2. Organising Authority**

## **3. Rules and Regulations**

The Regatta will be governed by the current Racing Rules of Sailing.

**Attention is drawn to the fundamental rules, 1, 2, 3 and 4.**

-Race starting flags are in use.

**-No “extras” to be used, (ie spinnakers or sail that cannot be carried upwind).**

## **4. Alteration of Racing Rules**

4.1 Rule 44.1 is replaced by one (1) penalty turn.

4.2 Local Rule – Jet Ski Area (restricted area marked by yellow markers on the northern bank). Boats entering this area must be disqualified.

4.3 Rule 35 Time limit apply, 15 minutes after the first boat finishes.

4.4 Protest fee \$100.

## **5. Advertising and Photographers rights**

Competitors give permission for video footage including drone and photographs of themselves and their boat to be published in any media for press, editorial or advertising purposes.

## 6. Safety

The Safety Category for this Regatta is QYA Category 7

## 7. Eligibility

Old style Gaff rigged boats, replicas, originals, trailerable or not.

YACHTS MUST HAVE SAIL NUMBERS OR VISIBLE LARGE NUMBERS ON THE BOAT

The regatta format is 3 short races, **results will be based on performance handicap calculated by the club handicapper and the club TopYacht program.**

Time limit 15 minutes after the first finishing boat.

The regatta is run in conjunction with the Noosa Come Together Festival held in the Lions Park next to the Noosa Yacht and Rowing Club.
